**Item #4a** – Request for a change to Parking Meter Fees (Article XV Sec 15-4) and Parking Meter Locations and Regulations (Article V Sec 5-9.5) from 15 minutes for twenty-five cents to 30 minutes for twenty-five cents effective July 1, 2006

**Item #4b** – Request for a change to Parking Meter Locations and Regulations (Article V Sec 5-9.1) with the addition of the following sentence (see bold text):

No Person shall park a vehicle for a period of time longer than two hours or as otherwise indicated, between the hours of 8:00AM and 6:00PM on any streets designated in this section **and the hours of 8:00AM and 8:00PM in any parking lots in Davis Square.** This restriction shall not apply on Sundays or during the hours of legal holidays ..... effective July 1, 2006
