Somerville Licensing Commission Rule 1.08.1. – Alcoholic beverages licensees are forbidden to make a sale or delivery of alcoholic beverages or alcohol to a person who is intoxicated.

Massachusetts General Laws Chapter 138, Section 69: Sales or Delivery to Intoxicated Persons Prohibited. No alcoholic beverage shall be sold or delivered on any premises licensed under this chapter to an intoxicated person. The date of the alleged offense is 6/20/14.
