REPORT OF THE COMMITTEE
ON LICENSES AND PERMITS

The Committee on Licenses and Permits convened on January 27, 2010, with Chairman Bruce Desmond presiding and Committee Members Aldermen Robert Trane and Maryann Heuston also present and voting. Also present were City Clerk John Long, Superintendent of Inspectional Services Ed Nuzzo and individuals having business before the committee.

188601 - Motorcycles and More LLC, 109 Bailey Rd.:

Mr. Michael Lemieux appeared before the committee, as requested, and discussed the operation of his business.

188566 - Top Cars of Boston dba Inman Motor, 39 Webster Ave.:

Mr. Salomon S. Junior appeared before the committee. Alderman Heuston expressed concern about the number of cars on the lot. The license allows for 30 cars and Mr. Nuzzo stated that it is a tight fit. Mr. Junior stated that he can fit 33 cars on the lot and told the members that the only time that cars are put on the street is when they are delivered to him. He also said that he rents 10 spaces on Washington Street and that he would like to obtain a commercial permit. Chairman Desmond spoke about safety at the site.
