REPORT OF THE COMMITTEE
ON LICENSES AND PERMITS

The Committee on Licenses and Permits convened on April 22, 2009, with Chairman Bruce Desmond presiding and Committee Members Aldermen Robert Trane and Maryann Heuston also present and voting. Also present were Superintendent of Inspectional Services George Landers, Attorney Richard DiGirolamo and interested members of the public.

Public Hearing - Extended Operating Hours for Wing Works

The owner spoke in favor of the petition and informed the members that the business revolves around late night delivery and noted that most of the business is for delivery to Harvard University.

Ms. Dura Windor spoke in opposition to the petition because she believes that it is dangerous for people to be out that late. Mr. Matthew Sullivan voiced his opposition to the petition and stated that there are enough young people drinking beer in the area already and that the late hours would make it worse. He also stated that the delivery drivers are not careful and that it would add to the noise level in the area.

Chairman Desmond stated that he would consult with Alderman Gewirtz before the committee votes on the item.

Public Hearing - Extended Operating Hours for Kee Kar Lau Restaurant

The owner, Mr. Lam, spoke in favor of the petition and told the members that he has been open until 1:30 AM for 15 years and noted that many of his customers are police officers on the night shift. Since there is not much lunch business, Mr. Lam is relying on the late night business to avoid being put into financial difficulty.

There were no speakers in opposition to the petition. Alderman Trane stated that he has had no complaints and that he has no objections to the petition. Mr. Landers also stated that he has never had a problem with this business.
